IN THIS SAME PERIOD, 8,786 HOUSEHOLDS WERE MEMBERS OF THE ORGANIZATION. THE GARDENS OPERATE A BOOKSTORE AND PLANT SHOP AND MANAGE ALL COMMUNITY OUTREACH EFFORTS. PROGRAM SERVICE REVENUE INCLUDES BOOKSTORE/PLANT SHOP SALES NET OF INVENTORY COSTS AND INCOME FROM PRIVATE EVENT RENTALS.
